

**SAN BENITO FIRE DEPARTMENT  
BURNING PERMIT**

PERMISSION IS HEREBY GRANTED TO \_\_\_\_\_ FOR

INSIDE/OUTSIDE THE CITY IN COMPLIANCE WITH THE FOLLOWING RULES AND REGULATIONS:

1. BURN SITE SHALL BE INSPECTED BY FIRE DEPARTMENT/ FIRE PREVENTION DIVISION.
2. BURNING WILL BE FROM SUNRISE TO 1:00 P.M. ONLY.
3. ALL OUTDOOR BURNING MUST BE COMPLETELY EXTINGUISHED AT THE COMPLETION OF THE CONTROLLED BURN ON THE DAY OF OCCURANCE.
4. NO BURNING WHEN WIND SPEED IS LESS THAN 6 M.P.H. OR GREATER THAN 20 M.P.H.
5. BURNING SHALL BE SUPERVISED BY A RESPONSIBLE ADULT AT ALL TIMES AND THE BURNING PERMIT SHALL BE POSTED AT THE BURN SITE. THAT PERSON MUST BE PRESENT AT ALL TIMES AT THE BURN UNTIL EXTINGUISHED.
6. IF A COUNTY BURN BAN IS ISSUED DURING PERMIT TIME THE COUNTY BURN BAN WILL SUPERSEDE THE PERMIT AND ALL BURNING CEASED UNTIL THE BAN IS LIFTED.
7. IT IS FURTHER UNDERSTOOD THAT IF WE RECEIVE ANY COMPLAINTS REGARDING THE BURNING, IT WILL BE NECESSARY TO EXTINGUISH AT ONCE.
8. THE SAN BENITO FIRE DEPARTMENT HAS THE RIGHT TO CEASE ALL BURNING IF WEATHER CONDITIONS ARE NOT FAVORABLE TO OUTDOOR BURNING.
9. MUST CLEAR, CLEAN OR DISC THE BURNSITE FOR A RADIUS OF AT LEAST ONE HUNDRED (100) FEET SURROUNDING EACH PILE OF VEGATATION. NO DEBRIS PILE SHALL BE HIGHER THAN 6FT IN HEIGHT.
10. NOTIFY POLICE DISPATCHER EACH TIME BEFORE BURNING, INCLUDING WEEKENDS, BY CALLING (956)361-3880. A 24 HOUR NOTICE IS REQUIRED.
11. ALL OUTDOOR BURNING MUST COMPLY WITH THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY OUTDOOR BURNING REGULATIONS RG-049.

IT IS FURTHER ORDERED THAT ANY PERSON WHO VIOLATES THE CITY ORDINANCE/CAMERON COUNTY RESOLUTION AND ORDER SHALL BE GUILTY OF A MISDEMEANOR AND WILL BE PROSECUTED.
